

THIS COURT ORDERS:

1. An interlocutory injunction that the Defendants, Judy Higginbottom, Jeannette John, Ms. Stacey Leech, James McKay, Betty Porter and Robert Shintah be restrained and enjoined from:
 - (a) entering or occupying the administration office of the Ts'kw'aylaxw First Nation ("TFN") located at 35100 Hwy 99 North, Lillooet, British Columbia (the "Administration Office"), upon the Ts'kw'aylaxw First Nation Reserve #1 ("TFN Reserve");
 - (b) impeding, obstructing, or interfering with the ingress or egress of any person to or from the Administration Office or any other premises or facility located upon the TFN Reserve;
 - (c) intimidating, threatening, molesting, assaulting any person entering or leaving the Administration Office or any other premises or facility located upon the TFN Reserve; and
 - (d) ordering, aiding, abetting, counselling, or encouraging either directly or indirectly any other person or persons to commit any of the acts set out in paragraphs 1(b) and (c) above; and

2. That approval as to the form of this Order by the Defendants be dispensed with.




